Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

N. 22nd St. - W. Stark St. to W. Fairmount Ave. (WT410160684) File Number 150118: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$170,000). The total estimated cost for this project including the requested amount is \$185,000. This project is anticipated to be completed during the 2018 construction season.

N. 23rd St. - W. Fairmount Ave. to the Lincoln Creek Pkwy. (WT410160683) File Number 150118: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$580,000). The total estimated cost for this project including the requested amount is \$600,000. This project is anticipated to be completed during the 2018 construction season.

N. Marshall St. - E. Pleasant St. to E. Brady St. (WT410150669) File Number 150232: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$130,000, Additional Funds). The total estimated cost for this project including the requested amount is \$430,000. This project is anticipated to be completed during the 2018 construction season.
