A substitute ordinance to further amend the 2017 rates of pay of offices and positions in the City Service.

This substitute ordinance changes the rates of pay in the following departments: Employes' Retirement System

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Part 1, Section 2 of ordinance File Number 160596 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 23, 2017 - November 5, 2017):

Under Pay Range 2LX, add the titles "ERS Database Administrator (3)", "ERS Server Administrator (3)", and "ERS Software Developer (3)"; and add footnote "(3)" to read as follows:

"(3) Recruitment at any point in the range with DER approval."

Part 2. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.
