THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$171,000 for a total estimated cost of these projects being \$4,216,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$171,000 with the total cost estimated to be \$4,216,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

4th Aldermanic District

Alley north of W. Highland Ave. - Old World Third St. to 170 feet west of Old World Third St. (SM495170068): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$57,000. This project is anticipated to be completed during the 2018 construction season.

N. Plankinton Ave. - W. Wells St. to W. Kilbourn Ave. (SM495170064): Relaying Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$49,000. This project is anticipated to be completed during

the 2018 construction season.

6th Aldermanic District

N. 17th St. - W. Nash St. to W. Vienna Ave. (SM495170066): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$106,000. This project is anticipated to be completed during the 2018 construction season.

7th Aldermanic District

W. Concordia Ave. - N. 25th St. to 115 feet m/l west of N. 25th St. (SM495170054): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$54,000. This project is anticipated to be completed during the 2018 construction season.

Sewer Easement 550 feet north of W. Auer Ave. - N. 33rd St. to the alley west of N. 33rd St. (SM495170067): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$43,000. This project is anticipated to be completed during the 2018 construction season.

N. 25th St. - W. Concordia Ave. to W. Hopkins Ave. (SM495170055): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$312,000. This project is anticipated to be completed during the 2018 construction season.

8th Aldermanic District

S. 25th St. - W. Becher St. to W. Grant St. (SM495170053): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$508,000. This project is anticipated to be completed during the 2018 construction season.

10th Aldermanic District

W. Clarke St. - N. 52nd St. to 120 feet m/l west of N. 52nd St. (SM495170052): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$38,000. This project is anticipated to be completed during the 2018 construction season.

N. 52nd St. - W. Lisbon Ave. to W. Center St. (SM495170051): Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$602,000. This project is anticipated to be completed during the 2018 construction season.

Area bounded by N. Hawley Rd. to N. Honey Creek Pkwy from W. Blue Mound Rd. to W. Dickenson St. (SM494170015): Sanitary Sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$2,260,000.

Green Alley between W. Cleveland Ave., W. Montana St., S. 49th St., and S. 50th St. (SM499170103): (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$1,000. The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2018 construction season.

S. 69th St. - 325 feet north of W. Cleveland Ave. to W. Cleveland Ave. (SM495170065): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$77,000. This project is anticipated to be completed during the 2018 construction season.

14th Aldermanic District

W. Vermont Ave. - E. Rhode Island Ave. to E. Oklahoma Ave. (ST211170217): Concrete pavement reconstruction. (Nonassessable Reconstruction Paving Fund -- \$30,000). The total estimated cost of this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2017-2018 construction season.

15th Aldermanic District

W. Cherry St. and N. 18th St. (ST211180155): Replace traffic calming speed hump(s). (Nonassessable Reconstruction Paving Fund -- \$1,000) The total estimated cost for this project including the requested amount is \$15,000. This project is anticipated to be completed during the 2017-2018 construction season

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
