# THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$129,400 for a total estimated cost of \$129,400.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$129,400. The total estimated cost of these projects is \$129,400.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

# 1st Aldermanic District

N. 48th St. - W. Villard Av. to W. Rohr Av. (ST211180154): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$6,700; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$8,700. This project is anticipated to be completed during the 2018 construction season.

#### 2nd Aldermanic District

N. 63rd St. - W. Capitol Dr. to W. Fiebrantz Av. (ST211180143): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$7,000; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$9,000. This project is anticipated to be completed during the 2018 construction season.

#### 7th Aldermanic District

N. 26th St. - W. Auer Av. to W. Townsend St. (ST211180140): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$16,500; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$18,500. This project is anticipated to be completed during the 2018 construction season.

N. 45th St. - W. Glendale Av. to W. Hampton Av. (ST211180152): Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund -- \$16,100; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$18,100. This project is anticipated to be completed during the 2018 construction season.

S. 31st St. - W. Scott St. to W. National Av. (ST211180141): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$8,700; Nonassessable Reconstruction Paving Fund -- \$2,300) The total estimated cost for this project including the requested amount is \$11,000. This project is anticipated to be completed during the 2018 construction season.

(Assessable Reconstruction Paving Fund -- \$7,800; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$9,800. This project is anticipated to be completed during the 2018 construction season.
- S. 18th St. W. Arthur Av. to W. Hayes Av. (ST211180138): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$9,700; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$11,700. This project is anticipated to be completed during the 2018 construction season. 14th Aldermanic District
- S. 7th St. W. Holt Av. to W. Ohio Av. (ST211180123): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$7,800; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$9,800. This project is anticipated to be completed during the 2018 construction season.

N. 33rd St. - W. Lloyd St. to W. North Av. (ST211180147): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$11,100; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$13,100. This

project is anticipated to be completed during the 2018 construction season.

N. 44th St. - W. Meinecke Av. to W. Wright St. (ST211180151): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$7,800; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$9,800. This project is anticipated to be completed during the 2018 construction season.

N. 48th St. - W. Meinecke Av. to W. Wright St. (ST211180129): Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$7,900; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$9,900. This project is anticipated to be completed during the 2018 construction season.

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances: and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, that the assessable portion for the projects are to be allocated in the 2018 budget as necessary; and, be it

Further Resolved, That if surplus 2017 assessable funds become available some or all of the 2018 budget projects may be funded with 2017 funds; and be it
