THE CHAIR

A substitute ordinance relating to traffic controls.

This ordinance establishes the above-mentioned traffic requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-9.5 of the Code relating to No Loitering on Medians is amended by adding the following:

At the intersection of West Park Hill Avenue and North 35th Street

Part 2. Section 101-13 of the Code relating to 35mph Speed Limits is amended by striking the following:

“South 60th Street between West Kinnickinnic Parkway and West Cold Spring Road”

“South 60th Street between West Oklahoma Avenue and West Forest Home Avenue”

“South 60th Street from the north City Limits just south of West Arthur Avenue to the south City Limit”

Part 3. Section 101-13-2 of the Code relating to 30mph Speed Limits is amended by adding the following:

South 60th Street between West Kinnickinnic Parkway and West Cold Spring Road

Part 4. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On West Calumet Road at West Port Avenue

On West Mt Vernon Avenue at North 63rd Street

On West Burnham Street and South 31st Street in all directions

On West Roundhouse Road and South 33rd Court in all directions
