Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$5,114,000 for a total estimated cost of these projects being \$5,548,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$5,114,000. The total estimated cost of these projects is \$5,548,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

2nd Aldermanic District

N. 81st St. - W. Villard Ave. to W. Custer Ave. (WT410180679) File Number 170019: Relaying water main. (Nonassessable Water Fund Budget Line 6410 -- \$70,000). The total estimated cost for this project including the requested amount is \$85,000. This project is anticipated to be completed during the 2018 construction season.

4th Aldermanic District

E. Michigan St. - N. Jackson St. to N. Van Buren St. (SM495150078) File Number 161154: Combined sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$376,000, Additional Funds). The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2018 construction season.
