Whereas, American Sewer Services and its employees have demonstrated, through inappropriate behavior and the display of hate symbols, a callous disregard for the values of the City and the residents of the diverse neighborhoods where these repairs and improvements are being made; and

Whereas, The Public Works Commissioner has executed an agreement with American Sewer Services, Inc., which is attached to this file, that:

- 1. Terminates one American Sewer Services, Inc. contract.
- 2. Rejects American Sewer Services, Inc.'s ' bid on an un-awarded contract.
- 3. Prohibits American Sewer Services from rebidding on the either of these contracts.
- 4. Stipulates American Sewer Services, Inc. will not contest any provision of this agreement.
