Resolution relative to acceptance and funding of a 2017/18 Wisconsin Internet Crimes Against Children.

This resolution authorizes the Milwaukee Police Department to accept and fund a continuation of a Wisconsin Internet Crimes Against Children Grant project from the Office of Juvenile Justice and Delinquency Prevention (OJJDP) through the Wisconsin Department of Justice- Division of Criminal Investigation, Internet Crimes Against Children (ICAC) Task Force Program in the amount of \$40,000.00. The purpose of the project is a coordinated effort to enhance the Wisconsin ICAC program and affiliate membership effectiveness in responding to online enticement of children by sexual predators.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Office of Juvenile Justice and Delinquency Prevention (OJJDP), for an Internet Crimes Against Children Grant; and

Whereas, The operation of this grant from 10/1/2017 to 9/30/2018 would cost \$40,000.00, of which 100% would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, the Police Department shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, Milwaukee Code of Ordinances; and, be it

1. Commit funds within the Project/Grant Parent of the 2017 Special Revenue-Grant and Aid Projects, the following amount for the program titled "Wisconsin Internet Crimes Against Children Grant":

- 2. Create the necessary Grant and Aid Project/Grant and Project/Grant levels; budget against these Project/Grant values the amount required under the grant agreement;
- 3. Establish the necessary City Share Project Values; and, be it

Further Resolved, That these funds are budgeted for the Milwaukee Police Department which is authorized to:

1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date.
