THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$250,000 for a total estimated cost of these projects being \$1,315,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$250,000 with the total cost estimated to be \$1,315,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

4th Aldermanic District

N. 8th St. - A point South of W. State St. to W. State St. (ST211180182): Concrete pavement reconstruction, replace curb and gutter and walk as necessary. (Nonassessable Reconstruction Paving Fund -- \$5,000). The total estimated cost of this project is \$50,000. This project is estimated to be completed during the 2018 construction season.

Handicap Ramp work to meet ADA requirements - High Impact 2018 Projects - second contract

(ST216180108): (Nonassessable High Impact Streets -- \$50,000). The total estimated cost for this project including the requested amount is \$1,000,000. This project is anticipated to be completed during the 2018 construction season.

2018 Sewer Structure Inspections (SM495180004): (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost of this project is \$40,000. This project is anticipated to be completed during 2018 construction season.

2018 Sewer Structure Requests (SM495180005): (Nonassessable Sewer Maintenance Relay Fund - \$10,000). The total estimated cost of this project is \$50,000. This project is anticipated to be completed during 2018 construction season.

Various Aldermanic Districts

2018 Underwater Dive Inspection - Bridges (BR100180104): Federal and State mandated underwater dive safety inspection of in-service bridges. (City Share Non-assessable Structure Fund -- \$175,000). The total estimated cost for this project is \$175,000. This project is anticipated to be completed during the 2018 construction season.
