An ordinance relating to the amendment of the Official Map of the City of Milwaukee.

113-32.0116

The adoption of this ordinance will update the Official Map of the City of Milwaukee.

Whereas, The Mayor and Common Council of the City of Milwaukee do ordain as follows:

There is hereby added to the City of Milwaukee Code a new section to read as follows:

Section 113-32.0116 the Official Map, as mentioned and provided for in Section 113-32, is hereby amended so as to include the following additions as shown in the report on file in the City Clerk's office.

1ST ALDERMANIC DISTRICT S.W. 1/4 Sec. 25, T.8N., R.21E. Official Map Atlas Page 171

1. North-south alley in the block bounded by West Silver Spring Drive, West Thurston Avenue, North 41st Street and North 42nd Street. The vacation of the unimproved portion of the north-south 14-foot wide alley.

N.E. 1/4 Sec. 6, T.7N., R.22E. Official Map Atlas Page 232 1. Unimproved portion of pedestrian lane in the area bounded by West Cornell Street, West Glendale Avenue, North Green Bay Avenue and North 20th Street. The vacation of a 19.08 foot wide pedestrian lane.
