An ordinance relating to the issuance of citations for illegal dumping. This ordinance authorizes the department of neighborhood services to issue citations for illegal dumping.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 200-19-2 of the code is amended to read:

200-19. Penalties.

2. In addition to other applicable enforcement procedures and pursuant to the authority of s. 66.0113, Wis. Stats., the department may issue citations pursuant to the citation procedure set forth in s. 50-25 to any person violating any provision of ss. >>80-44-2,<< 200-11, 200-20-2, 200-21.5, 200-22-5, 200-24, 200-42, 200-51.7,
