THE CHAIR

Resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$2,129,000 for a total estimated cost of these projects being \$28,018,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$2,129,000 with the total cost estimated to be \$28,018,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

### 1st Aldermanic District

Alley between W. Fairmount Ave., N. 51st St. and N. 53rd St. (SM499180006): Install permeable pavers (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$1,000). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2018 construction season.

N. 11th St. - W. Birch Ave. to W. Silver Spring Dr. (WT410190674) Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$4,000; Nonassessable Water Fund Budget Line 6410 -- \$11,000). The total estimated cost for this project including the requested amount is
