THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$2,701,100 for a total estimated cost of \$2,921,500.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$2,701,100. The total estimated cost of these projects is \$2,921,500.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

1st Aldermanic District

N. 49th St. -- W. Villard Ave. to W. Custer Ave. (ST211180105) File Number 160587: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6' width of tree border area), and grading. (Assessable Reconstruction Paving

Fund -- \$11,600; Nonassessable Reconstruction Paving Fund -- \$185,000). The total estimated cost for this project including the requested amount is \$215,000. This project is anticipated to be completed during the 2018 construction season.

2nd Aldermanic District

W. Carmen Ave. -- N. 68th St. to N. 76th St. (ST211140127) File Number 120251: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (15' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$12,100; Nonassessable Reconstruction Paving Fund -- \$450,000). The total estimated cost for this project including the requested amount is \$490,000. This project is anticipated to be completed during the 2018 construction season.

N. 87th St. -- W. Silver Spring Dr. to W. Fond du lac Ave. (ST211150112) File Number 131474: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$18,200; Nonassessable Reconstruction Paving Fund -- \$260,000). The total estimated cost for this project including the requested amount is \$300,000. This project is anticipated to be completed during the 2018 construction season.

N. Summit Ave. -- E. Locust St. to E. Kenwood Blvd. (ST211180113) File Number 160695: Concrete pavement reconstruction, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$26,100; Nonassessable Reconstruction Paving Fund -- \$375,000). The total estimated cost for this project including the requested amount is \$420,000. This project is anticipated to be completed during the 2018 construction season.

4th Aldermanic District

W. Clybourn St.-- N. 29th St. to N. 35th St. (ST211180180) File Number 180029: Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$11,300; Nonassessable Reconstruction Paving Fund -- \$33,700). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2018 construction season.

7th Aldermanic District

N. 44th St. -- W. Townsend St. to W. Keefe Ave. (ST211180185) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund -- \$5,000; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$7,000. This project is anticipated to be completed during the 2018 construction season.

N. 49th St. -- W. Locust St. to W. Chambers St. (ST211180186) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$6,700; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$8,700. This project is anticipated to be completed during the 2018 construction season.

- N. 53rd St. -- W. Keefe Ave. to W. Nash St. (ST211180187) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$3,200; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$5,200. This project is anticipated to be completed during the 2018 construction season. 8th Aldermanic District
- S. 28th St. -- W. National Ave. to W. Pierce St. (ST211180115) File Number 161438: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (5' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$11,600; Nonassessable Reconstruction Paving Fund -- \$150,000). The total estimated cost for this project including the requested amount is \$180,000. This project is anticipated to be completed during the 2018 construction season.
- S. 30th St. -- W. Greenfield Ave. to W. Scott St. (ST211180144) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$6,600; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$8,600. This project is anticipated to be completed during the 2018 construction season.

S. 91st St. - A point 300' south of W. Adler St. to W. Adler St. (ST211070132) File Number 051328: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (5' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$5,500; Nonassessable Reconstruction Paving Fund -- \$100,000). The total estimated cost for this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2018 construction season.

Verona Ct. -- S. 77th St. to S. 79th St. (ST211180114) File Number 160695: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$3,900; Nonassessable Reconstruction Paving Fund -- \$100,000). The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2018 construction season.
- S. 54th St. W. Midland Dr. to W. Forest Home Ave. (ST211180106) File Number 160587: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$3,600; Nonassessable Reconstruction Paving Fund -- \$135,000). The total estimated cost for this project including the requested amount is \$160,000. This project is anticipated to be completed during the 2018 construction season.

(Assessable Reconstruction Paving Fund -- \$4,800; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$6,800. This project is anticipated to be completed during the 2018 construction season.

This project is anticipated to be completed during the 2018 construction season.

N. 24th St. -- W. Clarke St. to W. Center St. (ST211180183) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$4,900; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$6,900. This project is anticipated to be completed during the 2018 construction season.

N. 41st St. -- W. Meinecke Ave. to W. Wright St. (ST211180104) File Number 160587: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (3' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$14,300; Nonassessable Reconstruction Paving Fund -- \$255,000). The total estimated cost for this project including the requested amount is \$290,000. This project is anticipated to be completed during the 2018 construction season.

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it
