THE CHAIR

Resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$127,000 for a total estimated cost of these projects being \$1,229,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$127,000 with the total cost estimated to be \$1,229,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

3rd Aldermanic District

1720 N. Arlington PI. (City of Milwaukee Parking Lot) (SM499180110) Permeable Pavers. (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$5,000). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2018 construction season.

2705 N. Downer Ave. (City of Milwaukee Parking Lot) (SM499180111) Permeable Pavers. (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$5,000). The

total estimated cost for this project including the requested amount is \$70,000. This project is anticipated to be completed during the 2018 construction season.

900 E. Locust St. (City of Milwaukee Parking Lot) (SM499180113) Permeable Pavers. (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$5,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2018 construction season.

5th Aldermanic District

Various streets (sponsored by the City of Wauwatosa) (ST211180213) Crackfilling (Nonassessable Reconstruction Paving Fund -- \$ 5,000) The total estimated cost for this project included the requested amount is \$5,000. This project is anticipated to be completed during the 2018 construction season.

6th Aldermanic District

N. Dr. Martin Luther King Dr. - 40' north of W. Lloyd St. to W. Garfield Ave. (SM495180025) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$112,000. This project is anticipated to be completed during the 2018 construction season.

7th and 15th Aldermanic District

W. Fond du Lac Ave. - W. Walnut St. to W. Roosevelt Dr. (WT410180012) Hydrant alteration. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund Budget Line 6410 -- \$12,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2018 construction season.

10th Aldermanic District

Various streets (sponsored by the City of Wauwatosa) (ST211180210) Sealing coating. (Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$10,000. This project is anticipated to be completed during the 2018 construction season.

11th Aldermanic District

S. 60th St. - W. Kinnickinnic River Pk to W. Morgan Ave. (WT410180011) Hydrant and water main alterations. (Nonassessable Water Fund Budget Line 5010 -- \$ 3,000; Nonassessable Water Fund Budget Line 6410 -- \$12,000.) The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2018 construction season.

W. Walker St. - S. 10th St. to S. 11th St. (SM495180027) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2018

S. 15th Pl. - W. Washington St. to W. Scott St. (SM495180022) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$101,000. This project is anticipated to be completed during the 2018 construction season.

S. 15th St. - W. National Ave. to W. Walker St. (SM495180023) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$94,000. This project is anticipated to be completed during the 2018 construction season.

14th Aldermanic District

2254 S. Allis St. (City of Milwaukee Parking Lot) (SM499180112) Permeable Pavers. (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$5,000). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2018 construction season.

S. Logan Ave. - E. Oklahoma Ave. to 200' south of E. Oklahoma Ave. (SM495180026) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$72,000. This project is anticipated to be completed during the 2018 construction season.

15th Aldermanic District

N. 27th St. - W. Brown St. to W. Lloyd St. (SM495180024) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2018 construction season.
