THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$8,500,800.05 for a total estimated cost of \$10,865,657.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$8,500,800.05. The total estimated cost of these projects is \$10865,657.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

6th Aldermanic District

N. Buffum St. - E. North Ave. to E. Meinecke Ave. (ST211170138) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund -- \$7,500; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$9,500. This

project is anticipated to be completed during the 2018 construction season.

- N. Palmer St. E. Vine St. to E. Reservoir Ave. (ST211180131) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$5,100; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2018 construction season.
- N. 1st St. E. Vine St. to E. Reservoir Ave. (ST211180122) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$5,000; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$7,000. This project is anticipated to be completed during the 2018 construction season.
- N. 5th St. W. North Ave. to W. Wright St. (ST211160125) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$16,500; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$18,500. This project is anticipated to be completed during the 2018 construction season.

7th Aldermanic District

- W. Hope Ave. -- N. Sherman Blvd. to N. 51st Blvd. (ST211180111) File Number 160695: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (5' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$28,000; Nonassessable Reconstruction Paving Fund -- \$700,000). The total estimated cost for this project including the requested amount is \$763,000. This project is anticipated to be completed during the 2018-2019 construction season.
- N. 38th St. N. Elmhurst Rd. to N. Montreal St. (ST211180103) File Number 160587: Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (6' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$2,500; Nonassessable Reconstruction Paving Fund -- \$225,000). The total estimated cost for this project including the requested amount is \$242,500. This project is anticipated to be completed during the 2018-2019 construction season.

S. 23rd St. -- W. Clayton Crest Ave to W. Abbott Ave. (ST211160130) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$11,500; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$13,500. This project is anticipated to be completed during the 2018 construction season.

(Assessable Reconstruction Paving Fund -- \$13,500; Nonassessable Reconstruction Paving Fund -- \$265,000). The total estimated cost for this project including the requested amount is \$308,500.
