THE CHAIR

Resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$212,000 for a total estimated cost of these projects being \$3,116,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$212,000 with the total cost estimated to be \$3,116,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

2nd Aldermanic District

W. Hampton Ave. - A point west of W. Lincoln Creek Dr. to a point east of W. Lincoln Creek Dr. (SM495180032) Relaying storm sewer. (Nonassessable Sewer Maintenance Relay Fund --\$12,000). The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2019 construction season.

W. Lincoln Creek Dr. - W. Armitage Ave. to W. Hampton Ave. (SM494180020) Relayiang sanitary sewer. (Infiltration/Inflow Reduction Fund -- \$12,000) The total estimated cost for this project

including the requested amount is \$76,000. This project is anticipated to be completed during the 2019 construction season.

6th Aldermanic District

W. Capitol Dr. - N. 2nd St. to N. Green Bay Ave. (WT410180014) Hydrant and water main alterations. (Nonassessable Water Fund Budget Line 5010 -- \$ 3,000. Nonassessable Water Fund Budget Line 6410 -- \$17,000) The total estimated cost for this project including the requested amount is \$200,000. This project is anticipated to be completed during the 2018 construction season.

N. 4th St. - W. Clarke St. to W. Hadley St. (SM495180033) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000) The total estimated cost for this project including the requested amount is \$350,000. This project is anticipated to be completed during the 2019 construction season.

N. 6th St. - W. Hadley St. to 400' N. of W. Hadley St. (SM495180029) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$122,000. This project is anticipated to be completed during the 2019 construction season.

7th Aldermanic District

N. 39th St. - W. Ruby Ave. to W. Courtland Ave. (WT410190003) Water main and lead service relays. (Nonassessable Water Fund Budget Line 5010 -- \$ 7,000; Nonassessable Water Fund Budget Line 6410 -- \$28,000) The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2019 construction season.

8th Aldermanic District

W. Lapham St. - S. 20th St. to S. 21st St. (SM495180028) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$94,000. This project is anticipated to be completed during the 2019 construction season.

10th Aldermanic District

N. 66th St. - W. Mt. Vernon Ave. to W. St. Paul Ave. (SM494180019) Relaying sanitary sewer. (Infiltration/Inflow Reduction Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$156,000. This project is anticipated to be completed during the 2019 construction season.

S. 17th St. - W. National Ave. to 400' south of W. National Ave. (SM495180030) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$130,000. This project is anticipated to be completed during the 2019 construction season.

S. Chase Ave. - W. Lincoln Ave. to W. Ohio Ave. (WT410180013) Hydrant and water main alterations. (Nonassessable Water Fund Budget Line 5010 -- \$ 5,000; Nonassessable Water Fund Budget Line 6410 -- \$20,000.) The total estimated cost for this project including the requested amount is \$300,000. This project is anticipated to be completed during the 2018 construction season.

15th Aldermanic District

W. Clarke St. - N. 39th St. to N. Grant Blvd. (SM494180021) Combined sewer lining. Relaying storm sewer. (Infiltration/Inflow Reduction Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$382,000. This project is anticipated to be completed during the 2019 construction season.

W. Vine St. - N. 32nd St. to N. 34th St. (SM495180031) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$350,000. This project is anticipated to be completed during the 2018 construction season.

N. 40th St. - W. Wright St. to W. Clarke St. (SM494180022) Relaying combined sewer. Relaying storm sewer. (Infiltration/Inflow Reduction Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$336,000. This project is anticipated to be completed during the 2019 construction season.

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it
