This ordinance changes the name of the public transportation review board to the public transportation, utilities, and waterways review board.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 320-16-0 of the code is amended to read:

320-16. Public Transportation >>, Utilities, and Waterways << Review Board.

Part 2. Section 320-16-1-a and f of the code is amended to read:

1. CREATED. a. There is created a public transportation >>, <u>utilities</u>, <u>and waterways</u><< review board consisting of 11 members. Eight members shall be appointed by the president of the common council and 3 members shall be appointed by the mayor >>,<< all to serve upon confirmation by the common

council.
f. Each member of the public transportation >>, utilities, and waterways<<< review board may name an alternate as provided in s. 320-4. A person named as an alternative by a member who is not subject to the city residency requirements of s. 320-3 shall also be exempt from the city residency requirement>>.<<
Part 3. Section 320-16-2 of the code is amended to read:
2 . MEMBER TERMS. All members of the public transportation >>, <u>utilities</u> , and <u>waterways</u> << review board shall serve terms of 3 years. Each member shall designate in writing an alternate to act in the absence of the member.
Part 4. Section 320-16-3-b of the code is amended to read:
3. DUTIES AND POWERS. b. Activities of the public transportation >>, utilities, and waterways review<< board shall include consideration of all modes of transportation >>, and public utility issues and operations of the city's waterways,<< and shall include consideration of the manner in which all modes of transportation and transportation facilities >>,<< such as transit stops and parking >>,<< interrelate to improve the efficiency, accessibility >>,<< and safety of transportation systems and promote the welfare of the public.
Part 5. Section 320-16-3-d of the code is amended to read:
d. The public transportation >>, utilities, and waterways<< review board shall report its activities and recommendations to the common council.
Part 6. Section 320-16-4 of the code is amended to read:
4 . STAFF. The city clerk shall provide staff support to the public transportation >>, utilities, and waterways << review board.
