THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$623,400 for a total estimated cost of \$680,100.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$623,400. The total estimated cost of these projects is \$680,100.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

4th Aldermanic District

N. 33rd St. -- W. Clybourn St. to W. Michigan St. (ST211180212) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund -- \$5,400; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$7,400. This project is anticipated to be completed during the 2018 construction season.

N. 80th St. -- W. Townsend St. to W. Keefe Ave. (including N. Walton Pl. - W. Lisbon Ave. to W. Townsend St.) (ST211180108) File Number 180159: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (5' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$10,000; Nonassessable Reconstruction Paving Fund -- \$200,000). The total estimated cost for this project including the requested amount is \$235,000. This project is anticipated to be completed during the 2018-19 construction season.

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it
