Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$5,553,000 for a total estimated cost of these projects being \$6,052,000

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$5,553,000. The total estimated cost of these projects is \$6,052,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

W. Fairmount Ave. - N. 47th St. to 30' east of N. 48th St. (WT410180646) File Number 170019: Relaying water main (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$88,000). The total estimated cost for this project including the requested amount is \$105,000. This project is anticipated to be completed during the 2018 construction

Luscher Ave. - N. 48th St. to N. 49th St. (WT410180649) File Number 170019: Relaying water main (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$93,000). The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2018 construction season.

N. 47th St. - W. Fairmount Ave. to W. Villard Ave. (WT410180647) File Number 170019: Relaying water main (Nonassessable Water Fund Budget Line 5010 -- \$5,000; Nonassessable Water Fund Budget Line 6410 -- \$420,000). The total estimated cost for this project including the requested amount is \$450,000. This project is anticipated to be completed during the 2018 construction season.

N. 48th St. - W. Luscher Ave. to W. Fairmount Ave. (WT410180648) File Number 170019: Relaying water main (Nonassessable Water Fund Budget Line 5010 -- \$5,000; Nonassessable Water Fund Budget Line 6410 -- \$275,000). The total estimated cost for this project including the requested amount is \$300,000. This project is anticipated to be completed during the 2018 construction season.

N. 49th St. - W. Luscher Ave. to W. Eggert PI. (WT410180650) File Number 170019: Relaying water main (Nonassessable Water Fund Budget Line 5010 -- \$5,000; Nonassessable Water Fund Budget Line 6410 -- \$695,000). The total estimated cost for this project including the requested amount is \$730,000. This project is anticipated to be completed during the 2018 construction season.

W. Capitol Dr. - 335' +/- east of N. 34th St. to N. 35th St. (SM494170010) File Number 171096: Relaying sanitary sewer. (Infiltration/Inflow Reduction Fund -- \$80,000 additional funds). The total estimated cost for this project including the requested amount is \$136,000. This project is anticipated to be completed during the 2018 construction season.

The total estimated cost for this project including the requested amount is \$225,000. This project is anticipated to be completed during the 2018 construction season.

N. 77th St./ W. Potomac Ave. -- W. Fiebrantz Ave. to N. 80th St. (WT410180667) File Number 170019: Relaying water main (Nonassessable Water Fund Budget Line 5010 -- \$4,000; Nonassessable Water Fund Budget Line 6410 -- \$526,000). The total estimated cost for this project including the requested amount is \$565,000. This project is anticipated to be completed during the 2018 construction season.

N. 84th St. (east side) - W. Hope Ave. to W. Marion St. - (WT410180605) File Number 161562): Relaying water main (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund Budget Line 6410 -- \$232,000). The total estimated cost for this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2018 construction season.

The total estimated cost for this project including the requested amount is \$110,000. This project is anticipated to be completed during the 2018 construction season.
