Whereas, Alderwoman Chantia Lewis has been appointed a member of the National League of Cities' 2018 Community and Economic Development (CED) federal advocacy committee; and

Whereas, It is a significant honor for the City of Milwaukee to have a member of its Common Council selected for this important post in a national organization that represents the interests of cities throughout the nation; and

Whereas, Participation on the NLC's CED federal advocacy committee will require the expenditure of funds for travel, lodging and related expenses; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Common Council authorizes the participation of Ald. Chantia Lewis as a member of the National League of Cities Community and Economic Development federal advocacy committee; and, be it

Further Resolved, That the City Clerk is authorized to expend funds from the City Clerk Office's Other Operating Services Account (Account Number 0001-1310-R999-636500) for travel, lodging and per diem expenses related to Ald. Lewis' attendance and participation at meetings of the NLC's CED committee and related official NLC business in her role as a member of this committee.
