THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$350,000 for a total estimated cost of these projects being \$6,069,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$350,000 with the total cost estimated to be \$6,069,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

3rd Aldermanic District

N. Lake Dr. at N. Downer Ave. (ST211180220) Install curb push out(s). (Nonassessable Reconstruction Paving Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$60,000. This project is anticipated to be completed during the 2018 -19 construction season.

E. Newport Ave. - N. Summit Ave. to N. Hackett Ave. (SM495180051) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$74,000. This project is anticipated to be completed during

the 2019 construction season.

4th Aldermanic District

N. Broadway - E. Highland Ave. to E. Juneau Ave. (SM495180043) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$125,000. This project is anticipated to be completed during the 2019 construction season.

N. Broadway - E. Kilbourn Ave. to 150' +/- south of E. Highland Ave. (SM495180049) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$185,000. This project is anticipated to be completed during the 2019 construction season.

W. Clybourn St. - N. 32nd St. to N. 35th St. (SM495180038) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$450,000. This project is anticipated to be completed during the 2019 construction season.

E. Highland Ave. - N. Market St. to N. Broadway (SM495180042) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$92,000. This project is anticipated to be completed during the 2019 construction season.

E. St. Paul Ave. (north-side) - N. Broadway St. to N. Water St. (ST211180231) Replace curb and gutter and sidewalk as necessary. (Nonassessable Reconstruction Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$40,000. This project is anticipated to be completed during the 2018 construction season.

N. 32nd St. - W. St. Paul Ave. to W. Clybourn St. (SM495180036) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$287,000. This project is anticipated to be completed during the 2019 construction season.

N. 34th St. - W. Clybourn St. to W. Michigan St. (SM495180037) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$156,000. This project is anticipated to be completed during the 2019 construction season.

6th Aldermanic District

W. Auer Ave. - N. 20th St. to N. 21st St. (SM495180055) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2019 construction season.

W. Center St. - N. Dr. Martin Luther King Jr. Dr. to N. 7th St. (SM495180050) Sanitary sewer relay and lining. (Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$785,000. This project is anticipated to be completed

during the 2019 construction season.

W. Concordia Ave. - N. 12th St. to N. 17th St. (SM495180021) Sanitary sewer relay and lining and relaying storm sewer.(Nonassessable Sewer Maintenance Relay Fund -- \$20,000). The total estimated cost for this project including the requested amount is \$661,000. This project is anticipated to be completed during the 2019 construction season.

W. Townsend St. - 120' east of N. 24th St. to N. 24th Pl. (SM495180053) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$155,000. This project is anticipated to be completed during the 2019 construction season.

N. 7th St. - W. Clarke St. to W. Center St. (SM495180054) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$198,000. This project is anticipated to be completed during the 2019 construction season.

N. 16th St. - W. Locust St. to W. Hopkins St.. (SM495180041)) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$89,000. This project is anticipated to be completed during the 2019 construction season.

N. 19th St. - W. Chambers St. to W. Hopkins Ave./ W. Burleigh St. (SM495180039) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$187,000. This project is anticipated to be completed during the 2019 construction season.

N. 24th St. - W. Hopkins St. to W. Townsend St. (SM495180052) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$188,000. This project is anticipated to be completed during the 2019 construction season.

6th and 7th Aldermanic Districts

W. Hopkins St. - W. Locust St. to W. Keefe Ave. (SM495180040) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$50,000). The total estimated cost for this project including the requested amount is \$1,446,000. This project is anticipated to be completed during the 2019 construction season.

7th Aldermanic District

N. 25th St. - W. Auer Ave. to 415' north of W. Auer Ave. (SM495180044) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2019 construction season.

8th Aldermanic District

S. 38th St. - W. Greenfield Ave. to 164' south of W. Orchard St. (SM495180035) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this

project including the requested amount is \$150,000. This project is anticipated to be completed during the 2019 construction season.

12th Aldermanic District

W. Burnham St. at W. Forest Home Ave. (Intersection modifications) (ST211180230) Replace curb and gutter and sidewalk as necessary. (Nonassessable Reconstruction Paving Fund -- \$8,000). The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2018 construction season.

W. Orchard St.-S. 12th St. to S. 14th St. (SM495180047) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$154,000. This project is anticipated to be completed during the 2019 construction season.

S. 13th St. - W. Orchard St. to W. Lapham Blvd. (SM495180046) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$212,000. This project is anticipated to be completed during the 2019 construction season.

S. Pennsylvania Ave. - E. Euclid Ave. to E. Fernwood Ave. (SM495180048) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$76,000. This project is anticipated to be completed during the 2019 construction season.

W. Vine St. - 160' east of N. 28th St. to N. 28th St. (SM495180045) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$79,000. This project is anticipated to be completed during the 2019 construction season.
