WHEREAS, Travaux Inc. solicited sealed bids by Official Notice Number 57875 during the period August 3, 2018 through August 28, 2018 for Elevators for Multi-Family Apartment Building 2.2 at Westlawn Gardens Phase 2; and

WHEREAS, two sealed bids were received by the deadline of 2:00 PM (CDST) on August 28, 2018; and

WHEREAS, the sealed bids were received and publicly opened on August 28, 2018, during which bidding procedure was conducted in compliance with the requirements of local, state, and federal regulations; and

WHEREAS, Schindler Elevator Corp., the lowest bidder and a qualified and competent bidder, submitted the lowest responsive and responsible bid in the amount of \$249,900.00, therefore, be it

RESOLVED, by the Board of Directors of Travaux Inc. that they hereby authorize and approve accepting the bid of and entering into a contract with Schindler Elevator Corp. for Elevators for Multi-Family Apartment Building 2.2 at Westlawn Gardens Phase 2; and, be it

FURTHER RESOLVED, that funds for these services will come from Westlawn Renaissance III LLC; and, be it
