Substitute 1

THE CHAIR

A substitute ordinance relating to traffic controls.

This ordinance establishes the above-mentioned traffic requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-7-2 of the Code relating to Non-Intersection crosswalks is amended by striking the following:

“On West State Street approximately 750 feet west of the west curb line of North 41st Street”

Part 2. Section 101-7-2 of the Code relating to Non-Intersection crosswalks is amended by adding the following:

On West State Street approximately 570 feet west of North 41st Street

Part 3. Section 101-9.5 of the Code relating to No Loitering on Medians is amended by adding the following:

At the intersection of West O'Connor Street and South 68th Street

At the intersection of West O'Connor Street and South 70th Street

At the intersection of West Kearney Street and South 68th Street

At the intersection of West Kearney Street and South 70th Street

Part 4. Section 101-15 of the Code relating to Yield signs is amended by striking the following:

“On West Cherry Street at North 21st Street”

“On North 49th Street at West Cherry Street”

“On North 49th Street at West Galena Street”

“On North 50th Street at West Vienna Avenue”

Part 5. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On West Cherry Street at North 21st Street

On North 49th Street at West Cherry Street

On North 49th Street at West Galena Street

On North 50th Street at West Vienna Avenue

On North 73rd Street at West Mt. Vernon Avenue
