# THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$72,500 for a total estimated cost of \$72,500.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$72,500. The total estimated cost of these projects is \$72,500.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

## 6th Aldermanic District

N. Booth St. - E. Glover St. to E. Meinecke Ave. (ST211180228) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund -- \$23,400; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$25,400.

This project is anticipated to be completed during the 2019 construction season.

N. 5th St. - W. Clarke St. to W. Center St. (ST211180236) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$7,700; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$9,700. This project is anticipated to be completed during the 2019 construction season.

N. 6th St. - W. Locust St. to W. Burleigh St. (ST211160154) Install traffic calming speed humps(s). (Assessable Reconstruction Paving Fund -- \$14,400; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$16,400. This project is anticipated to be completed during the 2019 construction season.

N. Norwood Pl. - W. Auer Ave. W./Louise Pl. to W. Roosevelt Dr. (ST211180174) Install traffic calming speed humps(s). (Assessable Reconstruction Paving Fund -- \$1,000; Nonassessable Reconstruction Paving Fund -- \$5,000). The total estimated cost for this project including the requested amount is \$6,000. This project is anticipated to be completed during the 2019 construction season.

## 12th Aldermanic District

W. Harrison Ave. - S. 13th St. to S. 16th St. (ST211180253) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$1,000; Nonassessable Reconstruction Paving Fund -- \$5,000). The total estimated cost for this project including the requested amount is \$6,000. This project is anticipated to be completed during the 2018--19 construction season.
