## THE CHAIR

Substitute resolution approving the 2019 monthly and quarterly solid waste collection charges for multi-unit dwellings with 5 or more units.

Whereas, Section 79-2-1-b of the Code of Ordinances directs the Department of Public Works to charge a fee to the owners of multiunit dwellings with 5 or more units to recover 100% of the cost of solid waste collection services; and

Whereas, This section of the Code stipulates that the amount of the solid waste collection fee shall be determined annually by the Commissioner of Public Works, subject to approval of the Common Council; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the following schedule of 2019 monthly and quarterly charges for collection of solid waste from multiunit dwellings with 5 or more units is approved:
