WHEREAS, Travaux Inc. solicited sealed bids by Official Notice Number 57901 during the period October 5, 2018 through October 26, 2018 for Finish Carpentry for Multi-Family Apartment Building 2.2 at Westlawn Gardens Phase 2; and

WHEREAS, two sealed bids were received by the deadline of 2:00 PM (CDST) on October 26, 2018; and

WHEREAS, the sealed bids were received and publicly opened on October 26, 2018, during which bidding procedure was conducted in compliance with the requirements of local, state, and federal regulations; and

WHEREAS, Cathedral Builders Inc., the lowest bidder and a qualified and competent bidder, submitted the lowest responsive and responsible bid in the amount of \$430,043.00, therefore, be it

RESOLVED, by the Board of Directors of Travaux Inc. that they hereby authorize and approve accepting the bid of and entering into a contract with Cathedral Builders Inc. for Finish Carpentry for Multi-Family Apartment Building 2.2 at Westlawn Gardens Phase 2; and, be it
