Resolution approving a contract to Milwaukee Millwork (Milwaukee, WI) for Unit Doors, Frames and Hardware (Commodity Only) for the Multi-Family Apartment Building 2.3 at Westlawn Gardens Phase 2 in the amount of \$155,000.00 (Official Notice No. 57910)

WHEREAS, Travaux Inc. solicited sealed bids by Official Notice Number 57910 during the period October 12, 2018 through November 2, 2018 for Unit Doors, Frames, and Hardware (Commodity Only) for Multi-Family Apartment Building 2.3 at Westlawn Gardens Phase 2; and

WHEREAS, one sealed bid was received by the deadline of 2:00 PM (CDST) on November 2; and

WHEREAS, the sealed bid was received and publicly opened on November 2, 2018, during which bidding procedure was conducted in compliance with the requirements of local, state, and federal regulations; and

WHEREAS, Milwaukee Millwork, the lowest bidder and a qualified and competent bidder, submitted the lowest responsive and responsible bid in the amount of \$155,000.00 therefore, be it

RESOLVED, by the Board of Directors of Travaux Inc. that they hereby authorize and approve accepting the bid of and entering into a contract with Milwaukee Millwork for Unit Doors, Frames, and Hardware (Commodity Only) for Multi-Family Apartment Building 2.3 at Westlawn Gardens Phase 2; and, be it
