The Chair

Substitute resolution relative to the acceptance and funding of the 2019 Women, Infants and Children’s (WIC) Grant from the State of Wisconsin Department of Health Services.

This resolution authorizes the Health Department to accept and fund the 2019 Women, Infants and Children’s Grant project from the United States Department of Agriculture through the Wisconsin Department of Health Services in the amount of \$1,287,625 comprised of \$1,277,625 grantor share and \$10,000 Program Income. The purpose of the project is to prevent nutrition-related health problems and to improve the health status of low-income, at-risk pregnant or breast-feeding women, infants and children up to the age of five years.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the United States Department of Agriculture through the Wisconsin Department of Health Services for supplemental nutritious food and nutrition education; and

Whereas, The operation of this grant project from 01/01/19 to 12/31/19 would cost \$1,287,625 comprised of \$1,277,625 (99.22%) grantor share and \$10,000 (0.78%) Program Income; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Wisconsin Department of Health Services is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2019-Special Revenue-Grant and Aid Projects fund the following amounts for the program titled Women's, Infant's and Children's Grant:

2. Create the necessary Special Revenue Fund -Grant and Aid Project/Grant and Project level values; budget to these Project/Grant Values the amount required under the grant agreement; and, be it

Further Resolved, That these funds are budgeted to the Health Department which is authorized to:

1. Expend from the amount budgeted sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date; and
2. Expend from the 2019 grant budget funds for training and out-of-town travel by departmental staff; and
3. 3. Expend from the 2019 grant budget funds for specific items of equipment; and
3. 4. Enter into subcontracts and leases as detailed in the grant budget; and, be it

Further Resolved, That the Common Council directs that the 2019 Positions Ordinance C.C. File Number 180629, should be amended as follows:
