PURCHASE TERMS AND CONDTIONS The purchase price is \$5,000. The conveyance will be on an "as is, where is" basis, including all environmental and geotechnical conditions, if any. The Buyer has agreed to a Payment in Lieu of Taxes (PILOT) Agreement that will be based on the value of the property after full development multiplied by the total City of Milwaukee and Milwaukee Public Schools tax rates. At closing, a commission will be paid to the commercial broker that submitted the offer on behalf of the Buyer. Also, a 30 percent disposition fee shall be paid to the Redevelopment Authority of the City of Milwaukee, less sale and marketing expenses, and the remaining proceeds shall be credited to the Delinquent Tax Fund.
