Sanitary Sewer Lateral Lining in Area Bounded By -- W. Glendale Ave. to W. Congress St. from N. 71st St. to N. 66th St. (SM494180048). Sanitary Sewer lining. (Infiltration/Inflow Reduction Fund -- \$20,000). The total estimated cost of this project including the requested amount is \$2,159,000. This project is anticipated to be completed during the 2020 construction season.
