THE CHAIR

A substitute ordinance to further amend the 2019 offices and positions in the City Service.

This substitute ordinance changes the offices and positions in the following departments:

Department of City Development, Fire and Police Commission, Health Department, Library, Department of Public Works

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Part 1, Section 1 of ordinance File Number 180629 relative to offices and positions in the City Service is hereby amended as follows:

Under “Department of City Development, Commercial Corridor Development”, add footnote designation “(Y)” to one position of “Economic Development Specialist”.

Under “Office of the Commissioner”, add footnote designation “(Y)” to one position of “Development Projects Manager”, one position of “Economic Development Specialist - Lead”, and one position of “Marketing and Communications Officer”.

Under “Real Estate and Development”, add footnote designation “(Y)” to one position of “Real Estate Specialist”, one position of “Assistant Director - Redevelopment Authority”, and one position of “Development Projects Coordinator”.

Under “Health Department, Office of Violence Prevention”, add one position of ReCAST Program Coordinator”.

Under “Fire and Police Commission”, delete one position of “Fire and Police Commission Risk Management Manager”, add one position of “Fire and Police Commission Risk Manager”, delete one position of “Fire and Police Commission Risk Management Auditor”, and add one position of “Fire and Police Commission Risk Auditor”.

Under “Department of Public Works - Infrastructure Services Division, Transportation Infrastructure Decision Unit”, add footnote designation “(Y)” to one position of “Engineer in Charge”.

Under “Transportation Operations Decision Unit”, add footnote designation “(Y)” to one position of “Engineer in Charge”.

Under “Department of Public Works - Water Works, Business Organization, Administration”, add footnote designation “(Y)” to one position of “Water Systems and Project Manager (X)”.

Part 2. Part 1, Section 1 of ordinance File Number 180629 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 1, 2018 - December 31, 2017):

Under “Library, Administrative Services Decision Unit, Auxiliary Positions”, delete one position of “Media Specialist” and add one position of “Library Marketing Specialist”.

Part 3. Part 1, Section 1 of ordinance File Number 180629 relative to offices and positions in the City Service is hereby amended as follows (Effective Pay Period 1, 2019 - December 30, 2018):

Under “Health Department, Office of Violence Prevention”, delete one position of “ReCAST Program Coordinator” and add one position of “Program Assistant III (H)(X)”.

Under “Disease Control and Environmental Health Services Division, Bioterrorism - CDC Public Health Preparedness Grant (A)”, delete one position of “Infectious Disease Epidemiologist (X)(Y)(A)” and add one position of “Infectious Disease Program Manager (X)(Y)(A)(T)”.

Part 4. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

Part 5. The provisions of Part 2 of this ordinance are deemed to be in force and effect from and after Pay Period 1, 2018 (December 31, 2017).

Part 6. The provisions of Part 3 of this ordinance are deemed to be in force and effect from and after Pay Period 1, 2019 (December 31, 2018).

The provisions of this ordinance are deemed to be in force and effect from and after its passage and publication.

Part 7. This ordinance will take effect and be in force from and after its passage and publication.
