WHEREAS, Builders FirstSource Inc., the lowest bidder and a qualified and competent bidder, submitted the lowest responsive and responsible bid in the amount of \$180,243.00, therefore, be it

RESOLVED, by the Board of Directors of Travaux Inc. that they hereby authorize and approve accepting the bid of and entering into a contract with Builders FirstSource Inc. for Residential Casework (Commodity Only) for Multi-Family Apartment Building 2.2 at Westlawn Gardens Phase 2; and, be it
