Resolution relative to acceptance and funding of a Juvenile Accountability Block Grant. This resolution authorizes application, acceptance and expenditure of the Juvenile Accountability Block Grant from the State of Wisconsin, Office of Justice Assistance.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin, Office of Justice Assistance for the Juvenile Accountability Block Grant to operate the School Safety Program; and

Whereas, The operation of this grant from 07/01/2009 to 06/30/2010 would cost \$81,284 of which \$8,128 would be provided by the city and \$73,156 would be provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Community Development Grants Administration shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2009 Special Revenue- Grant and Aid Projects, the following amounts for the program titled: "Juvenile Accountability Block Grant - School Safety Program":

1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date;

2. Expend from the 2009 grant budget funds for specific items of equipment;
