THE CHAIR

Resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$2,325,000 for a total estimated cost of these projects being \$24,444,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$2,325,000 with the total cost estimated to be \$24,444,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

### 1st Aldermanic District

W. Rohr Ave. - 300' east of N. 24th St. to N. 24th St. (WT410200606) Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; (Nonassessable Water Fund Budget Line 6410 -- \$12,000). The total estimated cost of this project including the requested amount is \$75,000.
