THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$199,000 for a total estimated cost of these projects being \$3,364,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$199,000 with the total cost estimated to be \$3,364,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

2nd and 7th Aldermanic Districts

N. 60th St. - W. Capitol Dr. to W. Hampton Ave. (WT410200003) Hydrant alteration. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost of this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2020 construction season.

3rd Aldermanic District

N. Humboldt Ave. - E. North Ave. to E. Keefe Ave. (WT410200002) Hydrant alteration.

(Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost of this project including the requested amount is \$120,000. This project is anticipated to be completed during the 2020 construction season.

4th Aldermanic District

W. St. Paul Ave. -- N. 6th St. to N. Vel R. Phillips Ave. (SM495190013) Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000.) The total estimated cost of this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2019 construction season.

Alley between N. 5th St. and W. Vel R. Phillips Ave. - W. St. Paul Ave. to 200' +/- W. of St. Paul Ave. (SM495190014) Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost of this project including the requested amount is \$53,000. This project is anticipated to be completed during the 2019 construction season.

6th Aldermanic District

N. Teutonia Ave. - W. Groeling Ave. to W. Capitol Dr. (WT410200001) Hydrant alteration. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost of this project including the requested amount is \$180,000. This project is anticipated to be completed during the 2020 construction season.

11th Aldermanic District

W. Oklahoma Ave. - S. 74th St. to S. 76th St. (WT410190500) Water main extension. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$33,000). The total estimated cost of this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2021 construction season.

W. Oklahoma Ave. - S. 76th St. to S. 84th St. (WT410190501) Water main extension. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$33,000). The total estimated cost of this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2021 construction season.

W. Oklahoma Ave. - S. 84th St. to S. 100th St. (WT410190502) Water main extension. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$13,000). The total estimated cost of this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2021 construction season.

10th Aldermanic District

N. 50th St. - W. State St. to W. Juneau Ave. (SM494190013) Sanitary Sewer lining. (Infiltration/Inflow Reduction Fund -- \$12,000). The total estimated cost of this project including the requested amount is \$166,000. This project is anticipated to be completed during the 2019 construction season.

City wide

Handicap Ramp work to meet ADA requirements for 2016 High Impact Projects (ST216190108): (Nonassessable High Impact Streets -- \$25,000). The total estimated cost for this project including the requested amount is \$1,000,000. This project is anticipated to be completed during the 2019 construction season.

Crackfilling of various streets by contract (ST211190132): (Nonassessable Reconstruction Paving Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2019 construction season.

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
