Resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$3,454,000 for a total estimated cost of these projects being \$4,517,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$3,454,000. The total estimated cost of these projects is \$4,517,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st Aldermanic District

N. 37th St. - W. Hampton Ave. to W. Fairmount Ave. (WT410160666) File Number 150118: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$665,000). The total estimated cost of this project including the requested

amount is \$690,000. This project is anticipated to be completed during the 2019 construction season.

3rd Aldermanic District

N. Prospect Ave. - E. Knapp St. to E. Curtis St. (SM495180016) File Number 171854: Relaying storm sewer and Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost of this project including the requested amount is \$89,000. This project is anticipated to be completed during the 2019 construction season.

4th Aldermanic District

N. Broadway -- E. Highland Ave. to E. Juneau Ave. (SM495180043) File Number 180399: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$135,000. The total estimated cost of this project including the requested amount is \$147,000. This project is anticipated to be completed during the 2019 construction season.

N. Broadway - E. Kilbourn Ave. to 150 +/- south of E. Highland Ave. (SM495180049) File Number 180399: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$116,000). The total estimated cost of this project including the requested amount is \$128,000. This project is anticipated to be completed during the 2019 construction season.

E. Highland Ave. - N. Market St. to N. Broadway (SM495180042) File Number 180399: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$106,000). The total estimated cost of this project including the requested amount is \$118,000. This project is anticipated to be completed during the 2019 construction season.

W. Auer Ave. - N. 88th St. to N. 89th St. - (WT410190631) File Number 171854: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$1,000; Nonassessable Water Fund Budget Line 6410 -- \$84,000). The total estimated cost of this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2019 construction season.

N. 88th St.-W. Auer Ave. to W. Concordia Ave. - (WT410190630) File Number 171854: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$223,000). The total estimated cost of this project including the requested amount is \$240,000. This project is anticipated to be completed during the 2019 construction season.

N. 92nd St. - W. Auer Ave. to W. Concordia Ave. (WT410160601) File Number 151289: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$20,000). (Additional funds \$20,000; Final Authority \$260,000). The total estimated cost of this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2019 construction season.

N. 38th St. - W. Glendale Ave. to W. Courtland Ave. (WT410160619) File Number 151289: Relaying

water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$70,000). (Additional funds \$70,000; Final Authority \$370,000). The total estimated cost of this project including the requested amount is \$440,000. This project is anticipated to be completed during the 2020 construction season.

N. 42nd St. - W. Glendale Ave. to W. Peck Pl. (WT410160618) File Number 151289: Relaying Water Main (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$20,000). (Additional funds \$20,000; Final Authority \$210,000). The total estimated cost of this project including the requested amount is \$230,000. This project is anticipated to be completed during the 2019 construction season.

W. St. Paul Ave. - 600' east of W. Greves St. to N. 25th St. (WT410180613) File Number 161562: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$3,000; Nonassessable Water Fund Budget Line 6410 -- \$377,000). The total estimated cost of this project including the requested amount is \$405,000. This project is anticipated to be completed during the 2019 construction season.

12th Aldermanic District

W. Pierce St. - S. 9th St. to S. 10th St. (WT410160649) File Number 150118: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0; Nonassessable Water Fund Budget Line 6410 -- \$155,000). The total estimated cost of this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2019 construction season.

Handicap Ramp work to meet ADA requirements for 2016 High Impact Projects (ST216190108): File Number 181686: (Nonassessable High Impact Streets -- \$975,000). The total estimated cost for this project including the requested amount is \$1,000,000. This project is anticipated to be completed during the 2019 construction season.

Crackfilling of various streets by contract (ST211190132): File Number 181686: (Nonassessable Reconstruction Paving Fund -- \$490,000). The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2019 construction season.
