113-32.0117

The adoption of this ordinance will update the Official Map of the City of Milwaukee.

Whereas, The Mayor and Common Council of the City of Milwaukee do ordain as follows:

There is hereby added to the City of Milwaukee Code a new section to read as follows:

Section 113-32.0117 the Official Map, as mentioned and provided for in Section 113-32, is hereby amended so as to include the following additions as shown in the report on file in the City Clerk's office.

1ST ALDERMANIC DISTRICT

S.E. 1/4 Sec. 24, T.6N., R.21E.

1. West Mill Road (north side) from North Teutonia Avenue west to a point. The opening of additional street right-of-way.

2ND ALDERMANIC DISTRICT

S.E. 1/4 Sec. 28, T.8N., R.21E.

1. North 76th Street at West Silver Spring Drive (northwest corner). The opening of additional street right-of-way.

3RD ALDERMANIC DISTRICT
