Whereas, The Historic Preservation Commission met on May 6, 2019 to consider granting a Certificate of Appropriateness for alterations to a previously approved storefront design at 814 - 816 W. Historic Mitchell Street in the Mitchell Historic District for Hector Salinas; and

Whereas, The Commission, by a vote of 4 ayes and two excused, voted to deny the Certificate of Appropriateness; and,

Whereas, The applicant filed an appeal of that decision on May 28, 2019; and

Whereas, The applicant and Historic Preservation Commission staff submitted a signed agreement dated July 20, 2020 in regards to how the work will be changed so it does meet Commission standards; and

Whereas, The Zoning, Neighborhood and Development Committee at its meeting of July 21, 2020 reviewed the agreement; and

Whereas, The Committee, by a vote of five ayes and zero noes, granted the appeal based upon the signed agreement in the file; now, therefore, be it,

Resolved, By the Common Council of the City of Milwaukee, that the appeal of the Certificate of Appropriateness for alterations to a previously approved storefront design at 814 - 816 W. Historic Mitchell Street in the Mitchell Historic District for Hector Salinas is granted.
