Substitute resolution approving construction of speed humps in the Historic Garden Homes Neighborhood Improvement District at various locations and appropriating funds for these purposes with the assessable portion of the costs to be paid by the Neighborhood Improvement District 6 - Garden Homes Operating plan funds with the total cost of the projects estimated to be \$47,300. This resolution directs the installation and construction of speed humps in the Historic Garden Home Neighborhood Improvement district. The total estimated cost of these projects is \$47,300. Whereas, Resolution 180880 approved NID-6 (Historic Garden Homes) Year 2 operating plan. The plan approved the paying of the assessable portion of the speed humps over a 5 year period; and

Whereas, the Year 2 operating plan allocates \$5,790 to the assessable portion for the speed humps; and

Whereas, the total portion that the NID-6 owes is estimated to be \$31,700 and will be included in the Department of Public works non-assessable developer account (ST214190103)

This project is anticipated to be completed during the 2019 construction season.
