This substitute ordinance changes the rates of pay in the following departments: Health Dept., Dept. of Public Works

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Part 1, Section 1 of ordinance File Number 180628 relative to rates of pay of offices and positions in the City Service is hereby amended as follows:

Under Pay Range 1DX, add footnote designation "(2)" to the title of "Fleet Repair Supervisor".

Under Pay Range 1FX, add footnote designation "(4)" to the title of "Fleet Repair Supervisor - Senior".

Part 2. Part 1, Section 2 of ordinance File Number 180628 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 10, 2019 - May 5, 2019):

Under Pay Range 2HX, add footnote designation "(4)" to the title of "Violence Prevention Manager".
