Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$215,700 for a total estimated cost of \$230,600.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$215,700. The total estimated cost of these projects is \$230,600.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

W. Mineral St. - S. 24th St. to S. 25th St. (ST211190111) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$3,100; Nonassessable Reconstruction Paving Fund -- \$4,100) The total estimated cost for this project including the requested amount is \$7,200. This

project is anticipated to be completed during the 2019 construction season.

- W. Mineral St. S. 25th St. to S. 26th St. (ST211180275) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$2,700; Nonassessable Reconstruction Paving Fund -- \$4,300) The total estimated cost for this project including the requested amount is \$7,000. This project is anticipated to be completed during the 2019 construction season.
- W. Rogers St. S. 23rd St. to S. 24th St. (ST211180268) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$3,700; Nonassessable Reconstruction Paving Fund -- \$3,100) The total estimated cost for this project including the requested amount is \$6,800. This project is anticipated to be completed during the 2019 construction season.

(Assessable Reconstruction Paving Fund -- \$9,100; Nonassessable Reconstruction Paving Fund -- \$160,000). The total estimated cost for this project including the requested amount is \$184,000. This project is anticipated to be completed during the 2019 construction season.
- S. 25th St. W. Holt Ave. to W. Ohio Ave. (ST211190113) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$8,000; Nonassessable Reconstruction Paving Fund -- \$2,000) The total estimated cost for this project including the requested amount is \$10,000.
