This resolution authorizes the Health Department to accept and fund the Congenital Disorders Program from the State of Wisconsin Department of Health Services in the amount of \$142,026. The purpose of the program is to screen newborns for numerous rare disorders.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin Department of Health Services to screen newborns for numerous rare disorders; and

Whereas, The operation of this grant program from 07/01/19 to 06/30/20 would cost \$142,026 entirely provided by the grantor; now, therefore, be it

1. Commit funds within the Project/Grant parent account of the 2019 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled Congenital Disorders Grant:

2. Create the necessary Special Revenue Fund - Grant and Aid Project/Grant and Project Levels; budget to these Project/Grant values the amounts required under the grant agreement; and be it

- 1. Expend from the amount appropriated sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
- 2. Expend from the 2019 grant budget funds for training and out-of-town travel by departmental staff; and,
- 3. Expend from the 2019 appropriated sums for total equipment indicated in the grant budget and incur cost consistent with the award date.
- 4. Enter into subcontracts as detailed in the grant budget; and, be it

Further Resolved, That the Common Council directs that the 2019 Positions Ordinance C.C. File Number 180629, should be amended as follows:

Amend footnote (O) to read as follows:

To expire 06/30/20 unless the Congenital Disorders Grant is extended. Also partially funds one position of Public Health Nurse.
