Resolution relating to acceptance and funding of a The Recycling Partnership grant.

This resolution authorizes the Department of Public Works - Operations Division (Sanitation Section) to accept and fund a grant from The Recycling Partnership in the amount of \$30,000 with a city share of \$0 and a grantor share of \$30,000. The purpose of the grant is to conduct a feasibility study of implementing uniform every other week recycling collection for all 1 - 4 unit households serviced citywide.

Whereas, The City of Milwaukee appears to be eligible for grant funds from The Recycling Partnership to conduct a feasibility study of implementing uniform every other week recycling collection for all 1 - 4 unit households serviced citywide; and

Whereas, The operation of this grant from 7/1/2019 to 12/31/2019 would cost \$30,000 of which, \$0 (0%) would be provided by the city and \$30,000 (100%) would be provided by the grantor; now therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Department of Public Works shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2019 Special Revenue - Grant and Aid
