78-6-3-k

This ordinance provides the commissioner of the department of neighborhood services may waive or modify the requirements for the placement and other aspects relating to beehives.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 78-6-3-k of the code is created to read:

## 78-6. Keeping of Honey Bees in the City.

## **3.** KEEPING OF HONEY BEE HIVES.

k. A permit application that is denied because it does not meet the standards of this subsection may

be appealed to the commissioner, who may waive or modify the requirements of this subsection consistent with professional practice guidelines promulgated by the University of Wisconsin system, Milwaukee County Extension, or other similar professional or academic material.
