WHEREAS, Travaux Inc. solicited sealed bids by Official Notice Number 57935 during the period June 14, 2019 through July 2, 2019 for Plumbing (HT-7.1) for Remodeling at Holton Terrace; and

WHEREAS, two sealed bids were received by the deadline of 2:00 PM (CDST) on July 2, 2019; and

WHEREAS, the sealed bids were received and publicly opened on July 2, 2019, during which bidding procedure was conducted in compliance with the requirements of local, state, and federal regulations; and

WHEREAS, Bohmann & Vick Inc., a qualified and competent bidder, submitted the lowest responsive and responsible bid in the amount of \$505,500.00; therefore, be it,

RESOLVED, by the Board of Directors of Travaux Inc. that they hereby authorize and approve accepting the bid of and entering into a contract with Bohmann & Vick Inc. for Plumbing (HT-7.1) for Remodeling at Holton Terrace; and, be it

FURTHER RESOLVED, that funds for these services will come from Holton Terrace LLC; and, be it

FURTHER RESOLVED, that the proper officers of Travaux Inc. be and hereby are authorized and directed to properly execute said contract for and on behalf of Travaux Inc.; and, be it
