The purpose of the grant is to provide public health testing and consultative services to the DHS/DPH and those local units of government authorized by DHS/DPH. Whereas, The City of Milwaukee appears to be eligible for grant funds from the Department of Health Services, Division of Public Health to provide public health testing and consultative services; and

Resolved, By the Common Council of the City of Milwaukee, that application of this grant from the DHS/DPH is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant parent of the 2019 Special Revenue Grant and Aid Projects Fund, the following amounts for the program titled Epidemiology and Laboratory Capacity Grant:

- 2. Create the necessary Special Revenue Fund Grant and Aid Project/Grant and Project Levels; budget against these Project/Grant values the amount required under the grant agreement; and, be it

- 1. Expend from the amount budgeted sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date; and
- 2. Expend from the 2019 grant budget for training and out-of-town travel by departmental staff;
- 3. Expend from the 2019 grant budget funds for specific items of equipment; and
- 4. Enter into subcontracts and leases as detailed in the grant budget; and, be it
