This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$3,046,000. The total estimated cost of these projects is \$3,321,000.

N. 11th St. - W. Birch Ave. to W. Silver Spring Dr. (WT410190674) File Number 171854: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$2,000; Nonassessable Water Fund Budget Line 6410 -- \$133,000). The total estimated cost of this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2020 construction
