WHEREAS, Merrill Park is one of the Public Housing Developments of the Housing Authority of the City of Milwaukee (HACM) that received Commitment for Housing Assistance Payments (CHAP) under the Rental Assistance Demonstration (RAD) portfolio award from the Housing and Urban Development (HUD); and

WHEREAS, the Housing Authority of the City of Milwaukee (HACM) received an allocation of Low Income Housing Tax Credits from the Wisconsin Housing and Economic Development Authority for the rehabilitation of Merrill Park; and

WHEREAS, HACM incorporated Merrill Park LLC to be the owner entity of Merrill Park Project; and

WHEREAS, HACM is the developer and the Managing Member of Merrill Park LLC through its wholly owned Limited Liability Company, Merrill Park Development LLC; and

WHEREAS, the President recommends that Travaux, Incorporated enter into a contract with Merrill Park LLC; now, therefore, be it

RESOLVED, by Travaux, Incorporated that they approve entering into a contract with the Housing Authority of the City of Milwaukee to be the construction manager at risk for Merrill Park project; and, be it

FURTHER RESOLVED, that the proper officers of Travaux, Incorporated are hereby authorized and directed to properly execute said contract for and on behalf of Travaux, Incorporated; and, be it
