THE CHAIR

A substitute ordinance to further amend the 2020 rates of pay of offices and positions in the City Service.

This substitute ordinance changes the rates of pay in the following departments:

Assessor's Office, Department of City Development, Employee's Retirement System, Health Department, Municipal Court, Department of Neighborhood Services, Police Department, Department of Public Works (Administrative Services Division, Infrastructure Services Division, Water Works)

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

**Part 1.** Part 1, Section 1 of ordinance File Number 190613 relative to rates of pay of offices and positions in the City Service is hereby amended as follows:

Under Pay Range 1DX, add footnote designations "(4)" and "(10)" to the title "Health Project Supervisor - DADS".

Under Pay Range 1JX, add footnote designations "(2)" and "(5)" to the title "Assessment Appeals Director".

Part 2. Part 1, Section 1 of ordinance File Number 190613 relative to rates of pay of offices and positions in

the City Service is hereby amended as follows (Effective Pay Period 24, 2019 - November 17, 2019):

Under Pay Range 1GX, delete the title of "Assistant Court Administrator".

Under Pay Range 1IX, add the titles of "Deputy Court Administrator (6) (13)" and "Court IT Manager (6) (13)".

**Part 3.** Part 1, Section 2 of ordinance File Number 190613 relative to rates of pay of offices and positions in the City Service is hereby amended as follows:

Under Pay Range 2LX, delete the title "Information Systems Manager - Milwaukee Police Department".

**Part 4.** Part 1, Section 2 of ordinance File Number 190613 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 24, 2019 - November 17, 2019):

Under Pay Range 2GX, add footnote designations "(8)" and "(17)" to the title of "Database Associate".

**Part 5.** Part 1, Section 3 of ordinance File Number 190613 relative to rates of pay of offices and positions in the City Service is hereby amended as follows (Effective Pay Period 23, 2018 - November 4, 2018):

Under Pay Range 3BN, delete the title of "Microfilm Technician 1 (1)(3)", delete footnotes "(1)" and "(3)" in their entirety, and reorder remaining footnotes accordingly.

**Part 6.** Part 1, Section 6 of ordinance File Number 190613 relative to rates of pay of offices and positions in the City Service is hereby amended as follows:

Under Pay Range 6HN, delete footnote designation "(5)" from the title "Accounting Assistant II" and add footnote designation "(6)" to the title "Accounting Assistant II".

- Part 7. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.
- **Part 8.** The provisions of Part 5 of this ordinance are deemed to be in force and effect from and after Pay Period 23, 2018 (November 4, 2018).
- **Part 9.** The provisions of Parts 2 and 4 of this ordinance are deemed to be in force and effect from and after Pay Period 24, 2019 (November 17, 2019).

The provisions of this ordinance are deemed to be in force and effect from and after its passage and publication.

**Part 10.** This ordinance will take effect and be in force from and after its passage and publication.
