WHEREAS, Westlawn Renaissance VI is one of the Housing Construction Phases (Phase 4B) of Westlawn Choice Neighborhood Project that received Commitment for Housing Assistance Payments (CHAP) under the Rental Assistance Demonstration (RAD) from the Housing and Urban Development (HUD); and

WHEREAS, the Housing Authority of the City of Milwaukee (HACM) received an allocation of Low Income Housing Tax Credits from the Wisconsin Housing and Economic Development Authority for the construction of 138 rental housing units; and

WHEREAS, HACM incorporated Westlawn Renaissance VI LLC to be the owner entity of this Project; and

WHEREAS, HACM is the developer and the Managing Member of Westlawn Renaissance LLC through its wholy owned Limited Liability Company, Westlawn Renaissance VI Development LLC; and

WHEREAS, the President recommends that Travaux, Incorporated enter into a contract with Westlawn Renaissance VI LLC; now, therefore, be it

RESOLVED, by Travaux, Inc. that they approve entering into a contract with Westlawn Renaissance VI LLCthe to be the construction manager at risk/constructor for Westlawn Renaissance VI (Phase 4B) project; and, be it
